Subject: Promotion to the post of Sister Grade-I at the AIIMS, New Delhi.

Consequent upon the recommendations of the Departmental Promotion Committee held on 7th November, 2014 and its acceptance by the Competent Authority, Ms. Meena Antony Rupwate, Sister Grade-II is promoted to the post of Sister Grade-I in the Pay Band-2 of Rs.9300-34800 with Grade Pay of Rs.4800/- notionally from 15.07.1998 i.e. the date of promotion of Ms. Mariamma John who was her immediate junior, and actual financial benefits will be accrued to her from the date of revocation of her suspension i.e. 23.06.2007.

She is advised to exercise her option for fixation of her pay under FR-22(I) either from the date of her promotion or from the date of drawal of her next increment in the present post within one month from the date of issue of this Office Order, provided she has not been granted Pay Band-2 of Rs.9300-34800 with Grade Pay of Rs.4800/- under ACP/MACP Scheme.

Other terms and conditions of their services will be the same as are applicable to other employees of the Institute.
