- Sub.: i) Admission of strongly suspected/ presumptive COVID-19 EHS beneficiary patients in New Private Ward Room No. 14-25 temporarily, awaiting result of lab. testing.
- ii) Exemption of diet charges for suspected/ confirmed COVID-19 EHS beneficiary patients admitted in New Private Wards.

It has been decided in the COVID-19 preparedness meeting under chairmanship of Director AIIMS held today morning in JLN Auditorium that :

i) Any EHS beneficiary patient (including Student Health Scheme beneficiary) who is provisionally diagnosed as strongly suspected/ presumptive patient of COVID-19 disease by the treating consultant of Medicine/ Emergency Medicine/ Pulmonary Medicine/ Geriatric Medicine, may be temporarily admitted in New Private Ward, Room No. 14-25 under Medicine Unit on call on that day (or Pulmonary Medicine/ Geriatric Medicine if so recommended by them) while awaiting result of their lab. testing. If the lab. test report comes as negative, he/ she will be immediately discharged by the Medicine Unit on call (or Pulmonary Medicine/ Geriatric Medicine if admitted under them) and if the lab. test report comes as positive, he/ she will be transferred to any vacant room in Room No. 2-12.

ii) Diet charges of Rs. 200/- per day on account of provisioning of private ward diet to such EHS beneficiary (or Student) patients, which is normally payable by the EHS beneficiary (or Student) patient himself/ herself, will be exempted for all suspected/ presumptive/ confirmed COVID-19 EHS (or Student) beneficiary patients being admitted in designated rooms in New private ward (Room No. 2-12 or Room No. 14-25) as a special case owing to exceptional/ rare situation.

Exemption of diet charges of Rs. 200/- per day for COVID-19 EHS (or Student) beneficiary patients being admitted in private wards will also be applicable to EHS (or student) beneficiary patients getting admitted in JPNA Trauma Centre Private Wards.
