**Subject : Debaring of M/s Roshan Enterprises – reg.**

The undersigned is directed to bring it to the notice of all concerned that **M/s Roshan Enterprises, 10, West Laxmi Market, Gali No. 3, Khureji Khas, New Delhi-110031** have been debarred from the Institute for a period of 3 (three) years with immediate effect from dealings and participating in all contracts, tenders etc. on the following grounds:-

- (a) The firm has failed to provide satisfactory services for repair of different type of sofas during the currency of Contract No. 05/H/Maint. Contract/2011-12.
- (b) The firm has failed to carry out the work of repairs against Letter of Intent No. 65/H/Rep. & Maint./13-14 dated 26.09.2013, 72/H/Rep. & Maint./13-14 dated 21.10.2013, 82/H/Rep. & Maint./13-14 dated 21.10.2013 and 86/H/Rep. & Maint./13-14 dated 25.11.2013.
- (c) The firm is non-responsive and has failed to respond our repeated telephonic calls and different letters dated 20.01.2014, 06.02.2014, 25.02.2014 and show cause notice dated 11.03.2014 and 17.04.2014.
- (d) The firm also failed to carry out the pending works despite the verbal assurances given by the firm in the personal hearing meeting held on 22.05.14.

The EMD/Security money of Rs. 5,000/- deposited by the firm vide DD No. 387467 dated 15.12.2011 against Tender No. 02/H/Rep. & Maint./2011-12 (Contract No. 05/H/Maint. Contract/2011-12 retained by the Institute as performance security against above mentioned contract has also been **forfeited**.

All Departments/Centers/Hospital are informed not to place any supply orders/work orders/tenders/ contracts etc. on the above mentioned firm henceforth.
