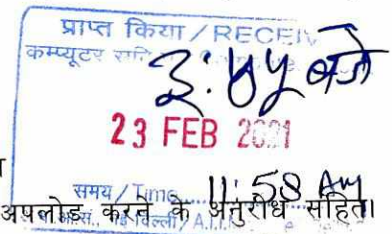

**Subject: EHS Benefits to the working/married daughters of employees.**

Sir,

Presently eligibility for EHS beneficiaries for their dependent daughter is till the time she starts earning, or gets married; whichever is earlier (irrespective of age). After attaining the age of 25 years the "Male" dependents beneficiaries are automatically deleted from the system and "Female" beneficiaries are continue the EHS benefits. Every year the employees (serving/pensioner) give in written to the EHS stating that "she is unmarried, not working and dependent on me".

There is no mechanism with the undersigned to ensure that the employee is not getting the EHS benefits for his/her working/married daughter. Nowadays, some cases are coming into knowledge of undersigned that some dependent daughters are working in some private organization or on contractual job but getting EHS Benefits.

Therefore, you are requested to kindly fix the responsibility of various Establishments to ensure that the names of only genuine and eligible dependent are included and delete the name of the ineligible dependent in the EHS token cards so that in future there will not any extension from the EHS side.
