**MINUTES OF THE MEETING**

**Subject: Joint Committee Meeting in the matter of Gaurav Sharma Vs. GNCTD in O.A. No. 202/2023 conducted on 16<sup>th</sup> November 2023 at 3:00 pm in Ramalingaswami Board Room, AIIMS, New Delhi -reg.**

A Joint Committee meeting was convened in the matter of Gaurav Sharma VS GNCTD in O.A No 202/2023 regarding implementation of recommendations of the Joint Committee as per directions of the Hon'ble National Green Tribunal (NGT) under the chairmanship of Director, AIIMS on 16th November 2023 at 3:00 pm in Ramalingaswami Board Room, AIIMS, New Delhi.

At the outset, Chairman welcomed the House and informed that the agenda of this meeting is to take account of the actions taken with reference to the decisions taken in the previous meeting.

The following points were discussed:

1. **Submission of Action taken report to Hon'ble NGT:** All concerned stakeholder were reminded that the action taken reports should be periodically submitted in a time bound manner as per OA No.: 202/2023, in order to upload on the AIIMS website and a comprehensive report of the same is to be submitted to the Hon'ble NGT at the end of 6 months.

2. **Integrated Plan for Traffic Management at AIIMS:** Chairman, Traffic Management Committee informed that the tender for signage's was floated and vendor was finalized. The material, content and location are to be decided for which advice maybe sought from Prof. Sewa Ram, Dept. of Transport Planning, School of Planning & Architecture.

**[Action: ESD and Security, AIIMS to coordinate with Transport Planning Department of SPA]**

3. **Traffic Management outside AIIMS: Congestion on high volume roads - MG road and Aurobindo Road:**

- a. **Encroachment by Hawkers, Vendors and Shops:** Delhi Police informed that the Hawkers and Vendors have been completely removed from the places of congestion. They also added that, any such transgressors are being actively vacated if any such were spotted during the course of their regular rounds.

**[Action: NDMC, Delhi Police]**

- b. **Increase in the number of Vehicles including taxis and auto rickshaws parked outside of AIIMS on Aurobindo Marg stretch:** Traffic Police informed that in order to discourage such parked vehicles outside AIIMS, challans are being issued to transgressors and till date 1263 vehicles were issued challans. Nevertheless, it has been observed that the Ambulances that have been displaced from their past locations are being parked at Gate no: 4 of AIIMS leading to shifting of congestion to the other side. It has also been informed that the Multilevel Parking under MCD is not being used properly and is mostly lying vacant. In this regard, it has been decided that the Traffic Police and NDMC may write to MCD regarding the same to allow Ambulances and other vehicles to be parked there. Traffic Police and NDMC agreed for the same.

5. **Setting up of AQI monitoring station and GRAP implementation:** It was informed that GRAP was being implemented as per the directives of Commission for Air Quality

Management (CAQM).ESD, AIIMS informed that the specifications were finalized and the proposal is put up for EAC to be held on 16.11.2023 and work would be initiated right after approval. ESD was reminded that the installation of AQI monitoring station is to be done in a time bound manner and any assistance needed maybe sought from DPCC/ CPCB.

**6. Traffic Management inside AIIMS:**

- a. Vehicular congestion at entry gates of AIIMS:** Contact numbers of Delhi Traffic Police are to be displayed on the sign boards to be installed along the entry gates in order to facilitate accessibility in case of any issue. Delhi Traffic Police are requested to share their numbers with the concerned departments.

**[Action: Delhi Traffic Police, ESD and Security & Traffic Committee, AIIMS]**

- b. Parking of vehicles, taxis and auto rickshaws at undesignated places inside AIIMS:**

In order to monitor the amount of time vehicles, taxis and auto rickshaws are spending inside the premises a non-monetary token system like at the Airports, is to be implemented inside AIIMS. It was also informed that some auto rickshaw drivers are operating exclusively within the campus and are showing resistance to comply to directives. In this regard, it was decided that a QRT may be deployed in order to keep a check on such auto rickshaw drivers.

**[Action: Security & Traffic Committee, AIIMS]**

- c. Increase in the number of vehicular traffic entering AIIMS:** The Chairperson, Traffic Management Committee informed that the Boom barriers have already been installed and the RFID enabled tags for in- house vehicles is under process. The proposed budget for the same has been put up for financial concurrence and the entire system is likely to be in place in another 3-4 months.

- d. Procurement of 200 electric vehicles for transportation of staff & patients:** It was informed that in first phase 30 electric vehicles of varying capacity will be procured by the Transport Committee at AIIMS. The budgetary requirement along with the timeline to be submitted to the Nodal Officer and action taken to be submitted in a time bound manner.

**[Action: Chairman, Transport Committee]**

- e. Slowing of speed of traffic:**

Chairman, Security & Traffic Committee informed that the decisions taken in the previous meetings were implemented which has eliminated the slowing of speed. On discussion, it was decided that advice may be sought from Prof. Sewa Ram, Dept. of Transport Planning, School of Planning & Architecture on the implementation.

**7. Green Belt inside AIIMS:**

ESD, AIIMS informed that the following measures have been implemented:

- a. A total of 2060 potted plants and 1000 trees were planted inside the premises of AIIMS
- b. Lawn and Park development in open areas
- c. Cleaning of horticultural and construction waste lying around in various areas of the premises

It was also informed that 1950 plants were assured for plantation at NCI through an order of the Hon'ble High Court which have not been delivered till date. ESD was directed to communicate with the Forest Department for following up on the same.

[Action: Chairman, Aesthetics & Beautification & ESD, AIIMS]

**8. Green Belt outside AIIMS:**

The Representative of NDMC informed that the tender for developing green belt in the outer area of AIIMS is under process. It was further informed that green belt in the outer area will be developed by NDMC.

[Action: NDMC, AIIMS]

**9. Dust Management at Construction Sites:**

For buildings that are being constructed/renovated in and around AIIMS campus, measures for managing/controlling dust are to be ensured in accordance with dust mitigation norms. It was informed by the ESD that all the necessary steps are being taken to meet the dust mitigation norms in AIIMS.

[Action- ESD, AIIMS & Other concerned Agencies]

- 10. Solid Waste Management:** It was informed by NDMC representative that the solid waste management around AIIMS campus is being supervised by the NDMC and large waste bins are being cleared on regular basis.

[Action-NDMC]

- 11. Illicit activities on foot over bridge and subways around AIIMS:** Delhi Police informed that the regular patrolling is being done along the foot over bridges and subways around AIIMS. Trespassers and other unwelcome crowd are being regularly vacated from these places.

- 12. Retrofitting of DG sets:** ESD informed that financial implication for retrofitting DG sets is put up in the EAC and approval is awaited.

[Action: ESD, AIIMS]

13. **Installation of ETP for the treatment of laundry effluent at AIIMS:** ESD informed that the process of tendering is ongoing and that the installation will likely be completed within a timeline of 4 months.

[Action: ESD, AIIMS]

14. **Installation of Pollution Mitigation System at AIIMS:** ESD informed that specs for the Pollution Mitigation System have been finalized and put up to EAC. Approval is awaited.

[Action: ESD, AIIMS]


15. **Speed breakers in the premises:** It was discussed that the speed breakers inside AIIMS maybe the cause for delay and slowing down of traffic and congestion. It was decided that this matter should be looked into for an optimal recourse.
