**MEMORANDUM**

**Subject:** Implementation of the Judgment delivered by the Hon'ble Supreme court of India vide SLP No. 11574/2020 dated 06.01.2021 (against WP (C) No. 4537 of 2016) titled "Union of India & Others Verses Sudesh Kumar & Others- Compliance of Hon'ble CAT order dated:15/07/2015.

Reference Office Memorandum of the even number dated 9<sup>th</sup> April, 2021 & 16<sup>th</sup> Aug.,2021, regarding revision of pay scales of Private Secretaries/Personal Assistants at the AIIMS, New Delhi subsequent to the decision of Hon'ble CAT's Principal Bench, New Delhi dated 15.07.2015 in OA No. 3335 of 2011. This issue was considered in meeting held on 23<sup>rd</sup> August, 2021 under the Chairmanship of Secretary (Health), it was decided that revision of pay scale of Private Secretaries /Personal Assistants may be implemented for all incumbents PSS'/PAs at AIIMS, New Delhi, in view of the order of the Hon'ble Supreme Court in the appeal made against the order of Hon'ble CAT dated 15.07.2015. This however will be subject to outcome of review petition being contemplated by the Department of Agriculture Research and Education (DARE), Ministry of Agriculture in the Hon'ble Supreme Court or any other Direction of DoE/Ministry in the matter.

Accordingly, the competent authority of the Institute has decided to comply with the order of the Hon'ble CAT, Principal Bench, New Delhi dated 15.07.2015 for revision of pay scales of all PSS/PAs at AIIMS, New Delhi, subject to review in case any further orders are received in this matter from Hon'ble Court/DoE/MoHFW.

The concerned Establishment Section may take further action for grant of above benefits and fixation of pay/placement in the revised pay scales for implementation of the aforesaid orders to all concerned.

Other contents of the O.M. 09.04.2021 will remain same.
