विषय:- अखिल भारतीय आयुर्विज्ञान संस्थान, नई दिल्ली में मेडिकल रिकॉर्ड तकनीशियन के पद पर नियुक्ति आदेश पत्र को रद्द/वापस करने के संदर्भ में।

Subect:- Offer of appointment to the post of Medical Record Technician at the AIIMS, New Delhi- cancellation/withdrawn thereof.

WHEREAS, Sh. Sanjeev Negi, Jr. Admn. Assistant, NDDTC was offered an appointment to the post of Medical Record Technician in the Pay Matrix Level -4 (Pre revised PB-1 Rs. 5200-20200+2400 GP) as per office order dated 21.10.2020.

AND WHEREAS, Sh. Sanjeev Negi has assumed the charge to the post of Medical Record Technician in her present deptt. on 21.10.2020 (F. N.) Accordingly his joining report was circulated vide office memo dated 30.12.2020.

AND WHEREAS, as per policy decision, the incumbents appointed against the post sanctioned/created for NCI, Jhajjar has to be posted at NCI, Jhajjar and accordingly, Sh. Sanjeev Negi was posted at NCI Jhajjar as per office memo dated 30.12.2020, as his appointed to the post of MRT was against the post created for NCI Jhajjar.

AND WHEREAS, Sh. Sanjeev Negi had not joined the post at NCI Jhajjar and submitted representation dated 05.01.2021 to the Director, AIIMS and informed that due to his family problem and non availability of safe transportation, he is unable to join the post at NCI Jhajjar and requested for posting at AIIMS New Delhi.

AND WHEREAS, his representation had been considered by the Competent Authority and decided that in view of policy decision in the matter, as referred above he has to join the post at NCI Jhajjar. Further, in case any willing MRT is available to work at NCI, Jhajjar, they will be considered for transfer mutually.

Accordingly, he was asked to join at NCI, Jhajjar within 10 days from the date of issue of vide office order dated 06.02.2021.

AND WHEREAS, in response of above he has neither joined nor given his refusal for the offer to the post in NCI, Jhajjar.

Now, therefore, the competent Authority has decided that the order of even no. dated 21.10.2020 regarding offer of appointment to the post of MRT in the Pay Matrix Level-4 in r/o Sh. Sanjeev Negi, **stands cancelled/ withdrawn** as he has not joined the post at NCI, Jhajjar. Therefore, the pay/arrear drawn on the post of MRT, if any will also be recovered.

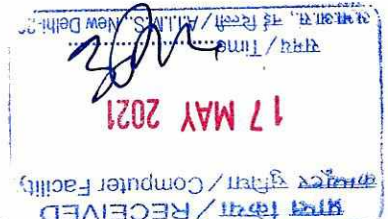
