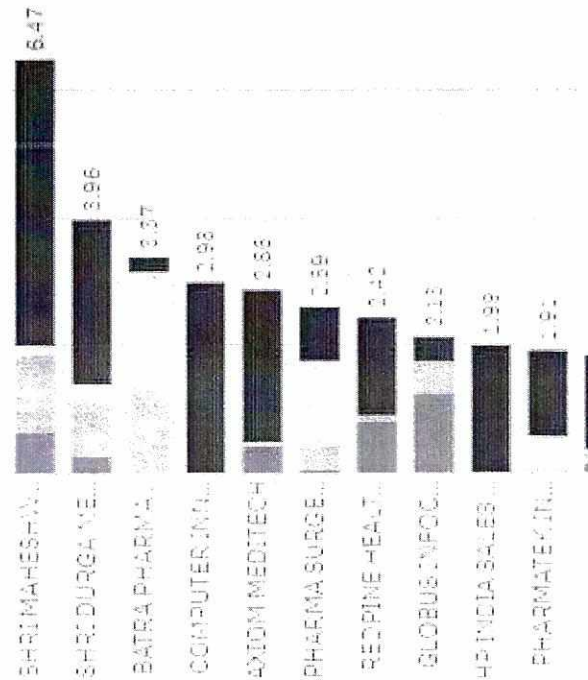

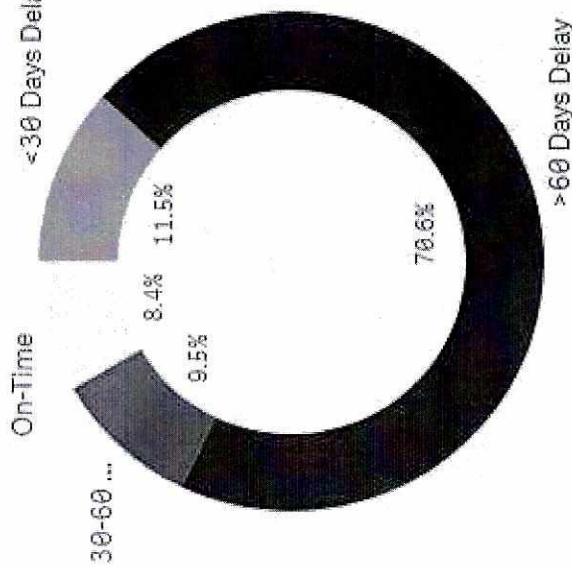

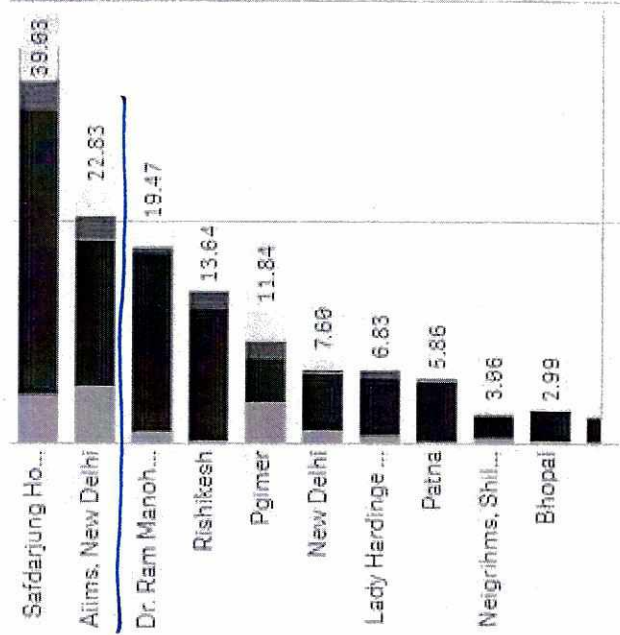

Ageing wise Payment Due



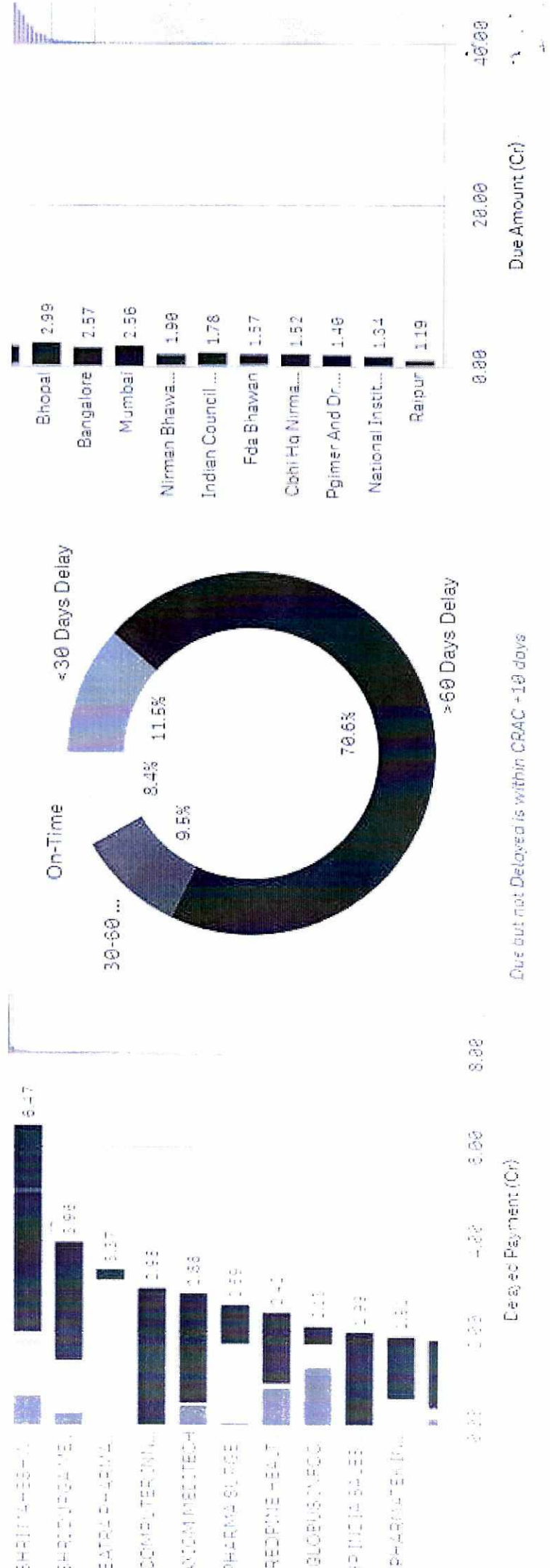
Office Name wise Due Amount

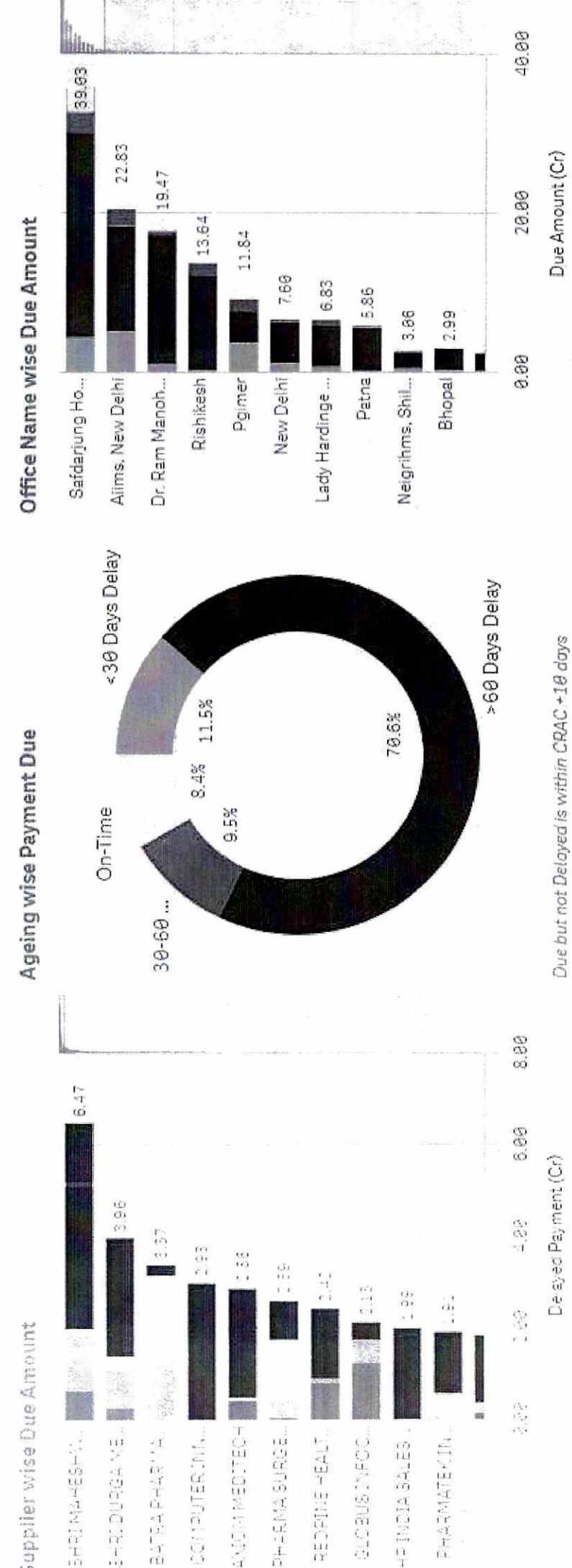

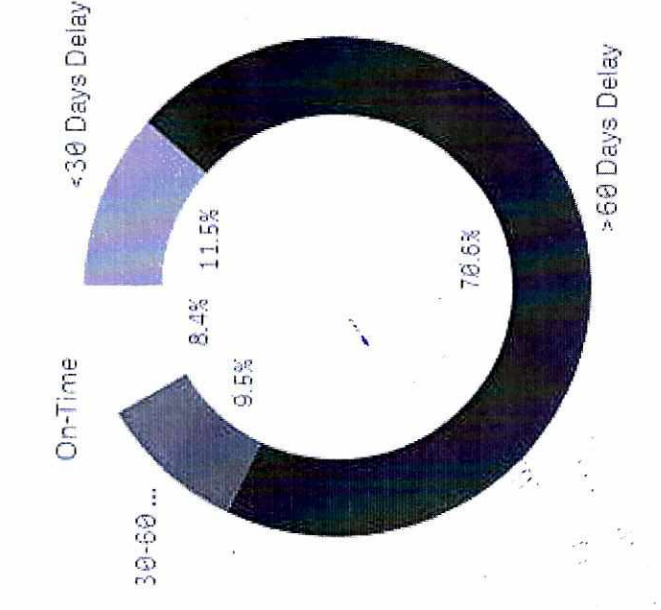
