- 6. Handwritten quotations shall be accepted at the bidder's risk. In case of any discrepancy in the figures, the rate mentioned in words only will be considered.
- 7. Each tender should be accompanied with an EMD/BID Security amounting to Rs. 5000/- by way of FDR/Demand draft drawn in favour of "THE DIRECTOR AIIMS, NEW DELHI" failing which the tender shall not be considered for acceptance and will be outrightly rejected. Cash / cheque is not acceptable at all. - 8. The Head, Department of Reproductive Biology, AIIMS, New Delhi shall be the final authority to reject in full or any part of the supply which is not conforming to the specification and other terms and conditions.
- 9. No payment shall be made for rejected material. The supplier should remove rejected items within one week of the date of rejection at their own cost & replace immediately. In case these are not removed, these will be disposed off in a manner deemed fit by the authorities at the risk and responsibility of the suppliers without any further notice.
- 10. The firm should submit an undertaking on firm's letterhead that it has not been blacklisted in the past by any government /private institution and there is no Vigilance/CBI case pending against the firm / supplier.
- 11. The quantity shown in the tender can be <u>increased</u> or <u>decreased</u> to any extent depending upon the actual requirement.
- 12. The firm must quote rates including freight, insurance, cartage, labor charge & other taxes etc. on FOB, AIIMS, New Delhi basis.
- 13. If required, the firm should be able to give demonstration of the item within one week of requisition. In case bidder, fails to give demonstration strictly in accordance with tender specifications, administrative action shall be taken like forfeiture of PBG & debarring of firm for minimum 02 years at AIIMS. The counter offer shall be given to L-2 bidder to match the L-1 price and to supply the item as per tender terms.

- 14. The court of Delhi will have the jurisdiction to try any matter, dispute or reference between the parties arising out of the contract. It is specifically agreed that no court outside and other than the Delhi court shall have jurisdiction in the matter.
- 15. Tender by Tele-fax /telegram /fax/e-mail will not be accepted.

16. Fall Clause:

"The price charged for the Stores/equipments, under the reference by the supplier shall in no event exceed the lowest price at which the supplier has supplied the Store/equipment of same identical description to any other person /organization/ Institution during the current financial year. <u>Specification for Bio- Safety cabinet - 1 No.</u>

Biosafety Cabinet (Class II Type A2 Biological Safety Cabinet) – Quantity: 1

- 1. It should be of vertical type airflow biosafety cabinet
- 2. Its horizontal size should be 1.2 meters (4 feet) with internal Work Area or at least (W x D x H) : 1220 x 580 x 660 mm
- 3. It must have an arm rest front armrest, raised above the workzone
- 4. It must have a Backlit LCD Display for simultaneously displaying inflow, downflow, sash status, airflowstatus, and filter life. Digital read-out with alpha-numeric display should indicate all input, status and alarm functions.
- 5. It should have an filter life display
- 6. Its tested opening should be of minimum 175 mm
- 7. Its average airflow velocity should be at least inflow: 0.45 m/s and downflow: 0.30 m/s
- 8. Its airflow Volume should be at least inflow: 345 cmh and downflow: 725 cmh
- 9. Its exhaust capacity should be at-least: 340cmh
- 10. It must have two ULPA filters with typical Efficiency of each: >99.999% at 0.1 to 0.3 micron, ULPA as per IEST-RP-CC001.3 USA>99.999% at MPPS, H14 as per EN 1822 EU
- 11. It must have two or more Blower for inflow and Downflow
- 12. It should produce low sound (Sound Emission NSF / ANSI 49 : 61.3 dBA, EN 12469 : 58.3 dBA)
- 13. Fluorescent Lamp Intensity (Lux) should be a minimum 1400 Lux
- 14. Cabinet main body should be made of at least 18 gauge electro-galvanized steel with white oven-baked epoxypolyesterIsocide antimicrobial powder coated finish
- 15. Its side walls should be made up of UV absorbing tempered glass, 5 mm (0.2"), colorless and transparent
- 16. For Microbiological, filteration and electrical Safety, Cabinets should meet most of the international standards
- 17. It should have an output port for remote monitoring of cabinet operating parameters.
- 18. Work area plates should be removable for autoclaving.

General Terms & Conditions

- 1. Power: 220-240V. FDA/CE/TUV/Appropriate International Certification should be enclosed.
- 2. The Vendor should have a good service and application support back up along with instruments to provide an effective application related troubleshooting and support.
