

Technical specifications for anaerobic jars / chambers that will function with existing Departmental anoxomat machine

1. The jars should be compatible with existing Anoxomat machine available in the Department.
2. The size of the jar should be such that it can accommodate multiple (3-4) 25 cm² tissue culture flasks (of standard companies) at the same time.
3. The jar should be transparent and have clip / gasket seal to allow sealed environment to be maintained.
4. It should have the capability of maintaining oxygen, CO₂ and N₂ gas concentration (individually or in combinations) for at least 48 hours in a sealed environment under pre-determined pressure defined by the user.
5. The jar should be able to withstand and maintain the pressure generated by the Anoxomat.
6. There should be a provision of evacuating and filling up the gas(es) to allow continuation of the desired gas concentration if required for longer durations of time.
7. The jar should be sterilizable and unbreakable.
8. Manufacturing defects (and other defects like lowering or loss of sealing efficiency) should be covered under warranty upto a period of at least one year.
