The quotations duly signed and marked as "Limited Tender 01/CRHSP/Ballabgarh/20-21" (PRICE BID) should reach the office of the Professor In-charge, CRHSP, Ballabgarh on or before 10.08.2020 at 5.00 P.M. All quotations should be type written or written with indelible ink. All over writing and erased entries will not be considered and treated as deleted entries from the quotations. The rates should be valid at least for one year. A clause by clause compliance statement should be submitted, failing which the quotation will not be considered.

The tenders are required to enclose with the quotation an Earnest Money of Rs.1,000/- (Rupees One Thousand only) through a demand draft/pay order drawn in favor of the "Director, AIIMS", failing which the quotation will not be considered. In case of failure to comply with the limited in terms of the contract, purchase will be made at the cost and risk of the contractors and or liquidated damages may be recovered from them. The period within which the goods can be supplied from the date of issue of the limited tender should be specified.

The opening of quotations/tenders (technical bid only) will be intimated to the bidders separately. The quantity shown in the Limited Tender can be increased or decreased to any extent depending upon the actual requirement.

Terms of Service:-

- Collection of municipal garbage approximately 300 kgs in a week.
- Collection of garbage to be done or twice a week basis.
- Contract for service will be made for three years without any change in rate for service.
- Collection and disposal of garbage in black garbage bags, as per current municipality guidelines will be responsibilities of the firm.

- 1. Registration of firm should be there.
- 2 The tenderer shall furnish a Non-blocking certificate that the firm has not been blacklisted in the past by any Government/Private institution. The Tenderer/Supplier has to give an affidavit on non-judicial stamp paper of Rs. 10/- duly attested by the notary that there is no vigilance/CBI case pending against the firm/supplier.
- 3. The tenderer shall furnish following certificates invariably along with technical bid, as applicable, otherwise quotation shall be summarily rejected:
 - a. A declaration by the proprietor of the firm, in case, the firm is proprietorship firm on non-judicial stamp paper of worh Rs. 100/- duly attested.
 - b. An attested copy of partnership deed duly registered by the Registar of Firms, in case, of partnership firm.
 - c. An attested copy of article of memorandum with constitution of firm and guidelines, in case of private limited firm with name, photo and signatures of all Directors.
 - d. Firm has to submitted bank details.
 - e. Firm has to submitted Pan Card No., GST No. & Adhar Card.
 - f. Authorization Certificate from MCH Haryana for Garbage/General Waste.
 - g. Firm has submitted experience certificate for Garbage and General Waste minimum 02 years or above.
- 4. The tenders should take care that the rates and amount are written in such a way that interpolation is not possible. No blanks should be left which would otherwise make the tender liable for rejection.
- 5. The rates quoted should be inclusive of all taxes and levels etc., Tender not confirming to these requirements are liable for rejection and no correspondence thereof shall be entertained whatsoever.
- 6. The tenderer should have been in this business for a periof of at least 03 years in NCR

 Delhi/Haryana in relation to the type of work which the quotations/tenders are being

 submitted. A declation to this effect should be given by the tenderer on a non-judicial

 stamp paper worth Rs. 10/- duly attested by a Notary Public.

- 7. The payment will be made to the contractor duly verified by the Faculty-In-Charge Sanitation. The bills shall be normally processed and paid within 30 days from the receipt of bills in triplicate duly Pre-receipted.
- 8. Approx. amount Rs. 32,400/- per year + GST (payment should be made on quarterly base by RTGS
- 9. Penal clause:- 10% of the annual cost will be deducted for delay in services for more than 2 occasion in a month.
- 10. Terms and condition for contract will be as per AIIMS, New Delhi. Contract can be terminated by AIIMS, by giving ONE-MONTH clear notice in advance. The approved contractor firm, if so desires can terminate the contract by giving THREE MONTHS clear notice in writing.
