# TECHNICAL SPECIFICATIONS INFUSION OR IV CANNULA INSERTION ARM TRAINER

- 1. Arm trainer with realistic looking special grade silicone skin
- 2. Skin quality should allow multiple punctures by trainees without leak
- 3. Easily palpable veins
- 4. Tubing of veins should be continuous and leak proof
- 5. Should give a real life like feeling of give way when vein punctured
- 6. Flash of blood coloured fluid should be visible if vein punctured correctly
- 7. Rechargeable blood fluid in a closed system with minimal chance of spillage should be available
- It should be possible o see, palpate and cannulated veins on dorsum of hand, forearm and cubital fossa
- 9. The arm should be provided with a stand to hold the arm steady during cannulation
- 10. The skin should be replaceable and spare skin to be provided with arm ( 2 sets at least)
- 11. Veins should be replaceable and extra 2 sets to be provided at least.
- 12. Bag for carrying and storing the above trainer
- 13. All accompanying accessories should be provided bottles with blood coloured fluid, pump for filling it, cannulae, syringes, lubricant, rigid carrying and storage bag.
