S.No.	Specifications
1.	The containers should be able to comply with painless, non-invasive and user-friendly sample collection.
2.	The sample should remain stable for minimum 2 years at room temperature.
3.	The containers should be compatible with downstream applications like NGS and Microarray.
4.	Saliva sample collected should be at least 2 ml.
5.	The DNA yield should be at least 100 µg.
6.	The containers should have US FDA/ CE Europe certification.
7.	Sample collection and stabilizing preservative in single container.
8.	Samples should be non- infectious and can be handled and shipped safely at ambient temperature.
9.	Compatible with most DNA isolation methods.
10.	Relevant literature along with a sample should be provided.
