Justification for upgrade of Hologic Selenia Mammography unit

C-View software can be used to reconstruct 2D images from 3D Mammography data without the need for 2D exposures thus reducing radiation dose by half.

Tomosynthesis biopsy helps to locate lesions seen only on tomosynthesis images, as well as lesions that are better visualized using 3D imaging. This new biopsy technique has numerous advantages over traditional stereotactic biopsy procedures, including faster lesion targeting, lower dose and reduced patient procedure time.

The Contrast Enhanced Digital Mammography (CEDM) Option used with the Selenia Dimensions 2D Full Field Digital Mammography System is an extension of the existing indication for diagnostic mammography with the Selenia Dimensions system. The CEDM application enables contrast enhanced breast imaging using a dual energy technique. This imaging technique can be used as an adjunct following mammography and/or ultrasound exams to localize a known or suspected lesion especially in dense breasts. Preliminary clinical studies have shown CEDM to be comparable to MRI in detection of malignancy.
