1.	Should have capability to convert the stretcher to at least five chair positions.
2.	Should come with Roll in technology for automatic loading and unloading into an ambulance.
3	L x W = 1980 x 580mm
4.	Should have a load capability of 290 kgs or above.
5.	Weight of the stretcher should be 30 kgs or less.
6.	Should be rectangular tubular aluminum construction.

7.	Length in chair position should be less than 1150mm to enable easy movement in confined areas such as hallways and elevators.
8.	Should have a single release mechanism changing the stretcher into anyone of the five positions.
9.	Should have lubrication free rotating components.
10.	Should have swing down side rails to enable convenient patient transfer.
