


### Technical specifications for Endotoxin Detection Kit

1. The kit should be of fast procedure completing in less than 60 minutes.
2. Assays must be of ELISA plate reading format.
3. Product size should be of 50 samples per kit.
4. Should be a chromogenic based detection system.
5. The kit should be highly sensitive with detecting limit not as  $>0.1$  EU/ml (approx.  $0.01\text{ng}$  endotoxin per ml).
6. Should be able to detect endotoxin from samples not  $> 5\text{-}15\mu\text{L}$ .
7. Should be able to detect Endotoxin from any biological samples and culture media.
8. Should be versatile and compatible with common Elisa plate readers.
9. The Kit should be FDA approved.
