


## Neuropathology Laboratory

### **Specifications for Antibodies**


1. The antibodies should be specific and there should be no cross reactivity with other proteins.
2. They should have long shelf life.
3. The antibody should be storable at  $2-8^{\circ}\text{C}$  or  $-20^{\circ}\text{C}$ .
4. Antibodies should be such that they can be used on formalin fixed paraffin-embedded tissue section and/ or frozen cryostat sections.
5. They should be usable in very high dilution with or without antigen retrieval. If antigen retrieval is required it should be using citrate buffer and microwave.
6. Antigen retrieval using proteolysis enzymes should not be required.
7. Firms are required to submit their quotation as per specification mentioned above all antibodies positively indicating the following points against each antibody. Firms not providing their quotation as per the following four points will not be entertained.
  - A. Recommended dilution range
  - B. Whether antigen retrieval required or not. If required, method of antigen retrieval
  - C. Usability in formalin fixed paraffin embedded tissue and/ or frozen tissues
  - D. Shelf life
8. Firms may be asked to submit a free sample of antibody for testing purposes, if required. If firm fail to supply the antibodies for test purpose they not be considered.
9. Data sheets of the antibodies and comparative statement to the tender specifications must be enclosed along with the reference page no. from the original catalogue of the company.
10. The price should be quoted in Indian rupees only.
