
The quoted items having quality mark such as I.S.I/C.E. mark/ISO9002 Standardization should be mentioned if any.

### **Specification for Antibody Diluent (18 nos.)**


1. The diluent should be specific and there should be no cross reactivity with other proteins.
2. The diluent should be storable at 2-8°C.
3. They should be compatible with primary antibody from rabbit, mouse and goat.
4. Minimum quantity of each reagent 100 ml.
5. They should have long shelf life.
6. Firms may be asked to submit a free of sample for testing purpose if required. If the firm fails to supply the antibody diluent sample for test purpose they are not considered.
7. The price should be quoted in Indian rupees only.
