- 1. It should be vertical single door freezer with temperature range-4°C to -20°C or lower.
- 2. It should have a capacity : Minimum 350 litres and weight should not be not more than 90kg
- 3. It should have a door alarm.
- 4. It should have 4\*star or greater rating and T climate class with A/A+ energy class.
- 5. Compressor should be capable to run with power supply : 240V/50-60Hz
- 6. It should be fully automatic operative
- 7. It should have external temperature display and temperature alarm
- 8. It should have the facility of auto defrost
- 9. Top model compact stabilizer should be provided with the freezer to stabilize fluctuating power supply.
- 10. Additional door lock should be provided
- 11. Warranty : 5 years onsite comprehensive including spears.
- 12. Penalty clause: In no case the instrument should remain in non-working condition for more than 7 days, beyond which a penalty of 2% of machine cost will be charged per day.
