### **Specification for Portable Blood Donor Couches**

### (Buy Back Basis)

[approx cost 4.5 lacs]

- 1. Mobile Foldable design.
- 2. Not more than 24"(W) X 66" (L) X 20 (H)
- Couch must be light weight (not to be more than 20 KG). It must have a comfortable mattress fitted for donor comfort.
- 4. Must be easy to clean and maintain
- 5. Must be in durable tubular non corrosive metal frame. The edges must not have sharp edges. (Edges can cause injury to the donor)
- 6. Must be able to bear the donor weight up to 150 Kg.
- 7. Must have padded armrest for the donor, adjustable for proper arm placement.
- 8. Couch can easily be reclined into a secured shock position
- 9. Pockets to be provided at the back of each couch for keeping accessories.
- 10. Must be provided with washable linen covers (1 pair) with each couch.
- 11. Must be sturdy.
- 12. Transportation trolley with wheels to hold two couches must be provided.
- 13. Original literature must be submitted
- 14. User's list must be provided with satisfactory report for the last three years from three Licensed Blood Banks with contact details.
- 15. Demonstration of performance of equipment is compulsory in Delhi/NCR failing which the firm will not be considered for technical evaluation.
