

To clear ambiguity regarding the process for procurement of proprietary items under Rule 166 (i) or (iii) of GFR 2017 at AIIMS - New Delhi, the following clarification is issued with the approval of Director AIIMS:

- **For proprietary items NOT available on GeM, the following process is to be followed:**
 1. Purchase proposal is forwarded to Store after vetting by appropriate TSEC (as per estimated cost) with:
 - GeM non-availability certificate
 - Compliance with Make in India directives
 - Compliance with directives for purchase from companies sharing land borders with India
 - Proprietary Article Certificate in prescribed format with justification of proprietary nature of the said purchase
 2. Specification, proprietary certificate, and proposal is uploaded on AIIMS website for 15 days after approval of Competent Authority
 3. TSEC addresses comments if any received on the said proposal after being hosted on AIIMS Website and justifies price reasonability and negotiates with vendor if required after approval of Competent Authority.
 4. SPC looks at procedural propriety if upfront purchase cost is over 1Cr.
 5. Proposal is then forwarded for FD concurrence and then for Administrative Approval & Expenditure Sanction

- **For proprietary items available on GeM, the following process is to be followed:**
 1. Purchase proposal is forwarded to Store after vetting by appropriate TSEC (as per estimated cost) with:
 - Compliance with Make in India directives
 - Compliance with directives for purchase from companies sharing land borders with India
 - Proprietary Article Certificate in GeM's format with justification of proprietary nature of the said purchase
 2. Approval of Competent Authority is sought to process the item as Proprietary Item purchase on GeM as direct purchase after uploading proprietary certificate on GeM or after PAC bidding as the case maybe as per GeM process for that item
 3. TSEC evaluates GeM bids in case of PAC bidding and justifies price reasonability and negotiates with vendor if required after approval of Competent Authority.
 4. SPC looks at procedural propriety if upfront purchase cost is over 1Cr.
 5. Proposal is then forwarded for FD concurrence and then for Administrative Approval & Expenditure Sanction
