On behalf of Director, AIIMS, New Delhi, A short rate enquiry (LIMITED TENDER) is invited in two (technical & Financial) bid to purchase of **Basic Life Support Manikin with Inbuilt Integrated Skill Reporter** (Units required – 2 nos) . The technical specifications are as under:

Technical Specifications

1. BLS manikin with torso, arms and removable jacket
2. It should allow head tilt, chin lift and jaw thrust maneuvers
3. It should have adjustable rigidity and stiffness to provide realistic resistance for chest compressions which allows the students to experience the amount of pressure needed to perform proper chest compressions in a real life situation.
4. The manikin should have anatomically correct landmarks and sternal notch which allows to practice identification of all anatomical landmarks relevant to adult CPR.
5. It should have facility to simulate Carotid pulse assessment manually.
6. It should have an in built feedback monitor which is integrated within the manikin that allows monitoring of chest compression depth, wrong hand position and ventilation volume.
7. It should have a hygienic system that protects students from cross-infection.
8. Should be supplied with at least 5 face pieces and 100 head bags
9. Should be supplied with a storage bag with mat.
10. The unit should have U.S. FDA approved/ CE (Europe) and ISO certification.
11. 2 year warranty with 3 year Comprehensive Maintenance Contract
12. Product Demonstration is required before the technical committee.
