Specification for Low temperature freezer (-20°C):

SI No	Description

- 1. Size: Preferable > 400L, frost free
- 2. Shape: Vertical
- 3. Refrigerant: Non-CFC
- 4. Temperature control: digital touch screen based interphase to give vital freezer information such as event log, settings and user profiles, with digital LED/LCD temperature display
- 5. Freezer set point -20°C, with presumed ambient temperature 40°C
- 6. Temperature Controller: Microprocessor/micro-controller based, precision 0.1°C
- 7. There should be positive, forced-air circulation to maintain temperature uniformity at all shelf levels
- 8. Doors: Preferable double solid doors. Hard industrial quality glass/solid, double door with long sturdy handles. Self-closing doors.
- 9. Door lock: should be provided with both the doors
- 10. Body: Puff / Maxi 2 / Polyurethane insulated and steel made and high impact powder-paint coated. Shelves/drawers: Adjustable, minimum no 4 to 8 shelves. Drawer racks for 3" boxes, standard micro plates, and deep well plates should be there.
- 11. Compatible boxes for frozen samples, as well as 0.2 ml, 0.5 ml and 2 ml PCR and Eppendorf tubes should be supplied with the freeze at no extra cost, for half of the inside rack volumes (Not optional). The rest of the space would be used for keeping kits, PCR places, chemicals, etc.
- 12. Illuminated interiors with door-activated ON/OFF switch; independent switch on control panel.
- 13. Heavy-duty, industrial-grade hermetically sealed compressors should be installed.
- 14. Automatic defrost for optimum cooling capacity.
- 15. Automatic condensate removal: no drain lines required.

- 16. Alarm: Audio-visual high and low temperature alarms. Alarms for open door and mechanical faults are also desirable.
- 17. Should be supplied with all standard accessories as per manufacturer catalogue for the model supplied
- 18. Castors: Needed with locking and regulators
- 19. Power supply: Capable of working on 220 volts +12 % A.C 50 Hz. Hospital grade Indian plugs.
- 20. Compatible stabilizer should be provided with the refrigerator at no additional cost.
- 21. Warranty: 5 years comprehensive warranty on compressor and cooling system; 3 years comprehensive warranty on electronic components.

22. 5 year AMC price should be included within the final quoted price and the same should not be included as optional item.

- 23. Penalty clause would be applied at a rate of 2% of machine cost/ day, if it remains at not working condition for >7 days, and also if the vendor fails to deliver the equipment ordered within specified time as appropriately decided by the institute at a rate decided by the purchase committee.
- 24. Undertaking from the specification committee stating that the specifications are broad based, general in respect to the requirement and not suit to any particular firm/brand.

Opening date of Bids is 28.01.2017 at 11:30 AM at Room 1050, Department of Pathology, AIIMS, New Delhi-29.
- 2. Registered firm must be authorized and have TIN No./ Registration No. (Please mention TIN/ registration no. on the bids or else the quotation will be REJECTED).
- 3. The bidder is required to submit **bid in two parts** viz

(a) Technical Bid in one envelope containing following information.

- i. Technical descriptions of quoted model/s
- ii. List of all consumables/accessories required to run the equipment
- iii. Terms & conditions including warranty/CMC/Taxes etc.
- iv. Original Catalogues of quoted model/s

4. The Earnest Money Deposit (EMD) of Rs. 6,000/- (Rs. Six Thousand only) In favour of 'Director, AIIMS, Delhi' In form of Account Payee Demand Draft, Fixed Deposit Receipt,

Banker's Cheque or a Bank Guarantee in acceptable form from any of the Scheduled Banks should be enclosed with Technical bid. Submission of EMD is mandatory in acceptable form, failing which their bid will be summarily rejected and no correspondence will be entertained in future in this regard. Any kind of exemptions giving MSME/NSIC in respect of EMD will not be acceptable.

- 5. The earnest money of the successful bidder and the unsuccessful bidders will be returned to them without any interest.
- 6. The offered make/brand should be mentioned on the bid. Relevant literature/original catalogue should be submitted along with the technical bid failing with item would not be considered.
- 7. Quotation should be typed/ written in ink. No overwriting or erased entries should be there in the quotation. The rates **should be valid for at least nine months**.
- 8. VAT/Sales tax or any other kind of tax(s) must be separately mentioned against each item. In case no sales tax is chargeable, prices must be quoted as NET PRICE.
- 9. Demonstration: The Purchaser reserves the right to ask for a free demonstration of the quoted equipment at a pre determined place acceptable to the purchaser for technical acceptability as per the tender specifications, before the opening of the Price Tender.
- 10. Warranty/Guarantee: The item must be covered under 5 years comprehensive warranty (Including all spares and labor) from the date of completion of the satisfactory installation. The warranty charges shall not be quoted separately otherwise the offer shall be summarily rejected.
- 11. Post Warrant CAMC: The bidders must submit their quote also (rates) for subsequent next (6th to 10th year) five years Comprehensive AMC (including all spares and labor) in their price bid. Failure to comply this condition will entail the rejection of the bids. The cost of CMC will be added for ranking/evaluation purpose

Undertakings:
