The quotations duly signed and marked as "SRE No.11/CRHSP/Ballabgarh/17-18" (PRICE BID & TECHNICAL BID separately) should reach the office of the Professor In-charge, CRHSP, Ballabgarh on or before 17.11.2017 at 05:00 PM. All quotations should be type written. All over writing and erased entries will not be considered and treated as deleted entries from the quotations. The rates should be valid at least for one year. **A clause by clause compliance statement should be submitted, failing which the quotation will not be considered.**

The tenders are required to enclose with the quotation an **Earnest Money of Rs. 5000/- (Rupees Five Thousands Only) through a demand draft/pay order drawn in favour of the "Director, AIIMS", failing which the quotation will not be considered.** In case of the failure to comply with the supply order in terms of the contract, purchase will be made at the cost and risk of the contractors and or liquidated damages may be recovered from them. The period within which the goods can be supplied from the date of issue of the supply order should be specified.


The offers submitted as quality A, B, C, & D etc., will be summarily rejected, any alteration/over writing in the specification / rates shall not be considered at all.

The opening of quotations/tenders (technical bid only) will be intimated to the bidders separately. The quantity shown in the Short Rate Enquiry can be increased or decreased to any extent depending upon the actual requirement.

Technical specification and the terms and conditions are attached.

Terms & conditions:

1. Demonstration of the equipment is must before awarding the tender.
2. The equipment should comply with USFDA/European CE standards.
3. Two years comprehensive warranty all spare parts and labour and three years AMC (2+3 years)
4. Original catalogue of quoted model should be provided along with tender documents.
5. Satisfactory performance from at least three users should be provided along with the technical bid.
6. The firm should submit a clause by clause compliance statement; price Reasonable Certificate, an undertaking on the official letterhead of the company that the firm has not been black listed and an undertaking on the official letter head of the company that no Vigilance case is pending against the firm.
7. Other standard AIIMS terms and conditions apply.
