The tenders are required to enclose with the quotation an Earnest Money of Rs.5,000/- (Rupees Five Thousand only) through a demand draft/pay order drawn in favor of the "Director, AIIMS", failing which the quotation will not be considered. In case of failure to comply with the supply order in terms of the contract, purchase will be made at the cost and risk of the contractors and or liquidated damages may be recovered from them. The period within which the goods can be supplied from the date of issue of the supply order should be specified.

The offers submitted as quality A, B, C, & D etc., will be summarily rejected, any alteration/over writing in the specification / rates shall not be considered at all.
