Kindly supply the rate **for antistatic antibacterial vinyl flooring** per sq ft. with full terms and conditions.

Specification:

Providing and fixing of 2mm thick PVC flexible homogeneous compacted anti-static floor covering of size 2mtrs x 20 mtrs. having **total weight 3250g/m2**.

It should features a stylish **non-directional design,** with a duotone chip decoration and three non-tonal highlight chips, incorporated with specially formulated **PUR** features a high quality, cross-linked **polyurethane reinforcement**, UV cured to provide a low cost, polish-free maintenance regime for the lifetime of the flooring and its surface should densely compacted for improving wear and ease of maintenance.

It should have **anti-bacterial and fungicidal properties** and complies with the EN 685 (34-43), making it suitable for very heavy commercial and heavy-light industrial use .It also should confirm to class Bfl-s1 in flammability test as per EN13501-1.

It should have slip resistance of R9 as per EN 13893 Class DS and very low VOC emission.

It should pas all the most stringent international VOC emissions tests, including AgBB, Floor Score and Indoor Air Comfort Gold from Eurofins. Along with positive VOC test results, there should be no evidence to suggest that it contributes to common allergies such as dust allergies or asthma and because of its superior Clean ability it should be used in the strictest of hygiene zones throughout in hospitals, labs etc.

It also should be non-Shedding and having Clean room approval certification for the same.

It should demonstrate from independent tests that it inhibits the growth of **MRSA** on the floor to prevent any kind of infection.

It should achieved a BRE Global Environmental A + Rating and a Green Tag LCA Rate certified with GreenRate level A- Gold Plus. From Independently assessed by the BBA (British Board of Agrement), it should be awarded a 10 year product performance assurance in the recommended use areas.

The floor finish should terminate at the room perimeter passing over a concealed cove former and continuing up the wall for 100mm. The joints in the flooring should be sealed by using a PVC welding bar of matching colour to be supplied by the manufacturer, using a hot air gun for fusion of welding bar with flooring.

The sub-floor should be dry, hard and smooth. The vinyl sheet shall be laid & fixed with water based adhesive preferably AROBOND-44 of M/s. Arofine make or VC 31 of M/s Pidilite Ind. or any other make as per manufacturer's specification as per direction and the entire satisfaction of Engineer-incharge complete.
