1. Rate enquiry should be addressed to the Stores Officer NDDTC, Room No.304, 2<sup>nd</sup> Floor, Administration Block, NDDTC, Ghaziabad and submitted, under sealed cover failing which the rate enquiry shall be rejected. Terms and conditions for supply should invariably be indicated otherwise would be taken on its face value.
2. THIS TENDER DOCUMENT/Rate Enquiry IS NON-TRANSFERABLE.
3. The bidder should give rates, showing taxes, levies, if any. Rate enquiry not confirming To these requirements shall be rejected and no correspondence will be entertained whatsoever.
4. The bid should be submitted in a separate cover envelope indicating thereon :

- 5 The rate enquiry forms be clearly filled in ink legibly or type written giving full address of the Tenderers/bidder . The bidders should quote in figures as well as in words the rates/amount quoted by the himself/them. Alterations/overwriting unless legible attested by the bidders, shall disqualify the Tenderers. The rate enquiry should be signed by the

bidders himself/themselves or his/their authorized agent or his/their behalf (Authorization may be enclosed, if applicable).

6. THE FORWARDING LETTER/ UNDERTAKING (SCHEDULE-A) DULY SIGNED by the tender SHOULD INVARIABLY be RETURNED ALONG WITH QUOTATIONS FURNISHED FAILING WHICH THE TENDER/Rate Enquiry SHALL BE REJECTED.
7. The bidders should take care that the rates and amount are written in such a way that interpolation is not possible no blanks should be left which would otherwise make the tender rejected.
8. EACH rate enquiry SHOULD BE ACCOMPANIED WITH AN EMD/BID SECURITY AMOUNTING TO Rs. 5,000/- BY WAY OF DEMAND DRAFT/ FDR/BANK GUARANTEE DRAWN IN FAVOUR OF "Account Officer NDDTC AIIMS Ghaziabad", AND THE SAME SHOULD BE FROM ANY SCHEDULED BANK FAILING WHICH THE rate enquiry SHALL NOT BE CONSIDERED FOR ACCEPTANCE AND WILL BE OUTRIGHTLY REJECTED. 9. Space should be left clear after lifting their belongings by the approved vendor failing which EMD/BID SECURITY will be forfeited.
10. Successful bidders shall have to lift their Condemned miscellaneous Condemned and surplus goods FIVE (5) working days of the issue of the gate pass by Stores Section (NDDTC) subject to full payment by the bidders, during working days (i.e. upto) 12.00 p.m. noon on Saturday and upto 5.00 P.M. in all working ) failing which a ground rent @ Rs.500/- per day will be charged till the final lifting of the goods by tenderers. No shifting will be permitted on Sundays and Govt. Holiday. Selected parties (highest bidder) shall be allowed to lift or load condemned goods only after issue of gate pass by the Stores Section (NDDTC).
11. Force majeure will be accepted on adequate proof thereof.
12. The Chief NDDTC, AIIMS New Delhi shall be the final authority to reject full or any part of the rate enquiry which is not fulfil the terms and conditions stipulated in the rate enquiry.

13. Bidders submitting rate enquiry would be considered to have accepted all the terms & conditions. No Inquiry verbal or written shall be entertained in r/o acceptance or rejections of the rate enquiry .
14. Any action on the part of the bidders to influence anybody in the said Institute will be taken as an offence. He will not be allowed to participate in the tender inquiry and his rate enquiry will not be opened.
15. The selected bidders shall have to start lifting of awarded items on the very next working day after depositing full bid amount failing which the EMD will be forfeited.
16. Any damage to the property of the NDDTC AIIMS IF NOTICED, DUE TO THE FAULT OF THE SUCCESSFUL BIDDER DURING LIFTING THE ITEMS SHALL BE RECOVERED FROM THE SAID FIRM AND THE DECISION OF THE Chief,NDDTC, AIIMS/CHAIRMAN A/B SHALL BE BINDING ON THE BIDDER.
17. Decision of the Chief,NDDTC will be final on all issues/objections, and no inquiry will be entertained after tender opening.
18. Tender by Tele-fax/telegram/fax/e-mail will not be accepted.
19. ALL THE LIABILITIES REGARDING TAXES/LEVIES WILL BE UPON THE SUCCESSFUL BIDDER ONLY.
20. If the bidders gives a false information shall be disqualified and removed from the list of approved vendors. No business, henceforth, will be done with the firm.
20. The courts at Delhi will have the jurisdiction to try any matter, dispute or reference between the parties arising out of the contract. It is specifically agreed that no court outside and other the court shall have jurisdiction in the matter.
