The rates should be valid at least for one year. **A clause by clause compliance statement should be submitted, failing which the quotation will not be considered.**

The tenders are required to enclose with the quotation an **Earnest Money of Rs.5,000/- (Rupees Five Thousand only)** through a demand draft/pay order drawn in favor of the **"Director, AIIMS"**, failing which the quotation will not be considered. In case of failure to comply with the supply order in terms of the contract, purchase will be made at the cost and risk of the contractors and or liquidated damages may be recovered from them. The period within which the goods can be supplied from the date of issue of the supply order should be specified.


The offers submitted as quality A, B, C, & D etc., will be summarily rejected, any alteration/over writing in the specification / rates shall not be considered at all.

Technical Specification of Loading Trolley Qty - 05 Nos.

1. 49"L X 27" W X 36") including wheel.
2. Should be done with 40mm x 40mm x 4mm in MS angle and mesh should be in 3"x1"x3mm (2"x3mm strip must be fixed in centre side support) with rust proof painting.
3. Forged revolving plate type rubber wheel with diameter 200mm x 50mm x (With heavy duty double ball bearing handle side).
4. Heavy duty castor rubber wheel should be fixed with the diameter of 8"x2".
5. Rare wheel fixed and back wheel revolving (Handle side).
6. Quality of wheel should be forzing type.
7. Loading capacity of loading trolley should be 1000 kgs.
8. Loading trolley weight should be more than 50kgs.
9. Made with 16 gauge MS Sheet and corner of the sheet should be attached in well manner.
10. Loading trolley should be made up of good quality mild steel.
11. Trolley should not have any sharp edges.
12. Loading trolley should be powder coated.
