<u>Technical specifications for Automated Plasma Thawing bath, Table Top Model (One no)</u>

- 1. Table top model, compact size for quick thawing of plasma at 37°C. Must have LED display.
- 2. The automated plasma thawing system must use controlled temperature to ensure the safety of the plasma.
- 3. It should have the capacity to thaw up to 12 plasma bags at a time.
- 4. It must be convenient and easy to operate, allowing you to load, set the required temperature and walk away.
- 5. Cabinet Construction: Must be made of High density CFC Free Poly Urethane Foam insulated cabinet with corrosion resistant stainless steel interior and the outer body made of mild steel duly powder coated.

6. Features:

- a. Microprocessor Digital temperature controller with audible and visual high temperature alarm. It must have accuracy of +0.1deg C. Display of Set value & Process value.
- b. Tank must be made of rust free polished stainless steel with baskets also made of SS.
