- 2. Should have visual alarm for open lead.
- 3. Should have a built in LCD display for heart rate, time, date, rhythm leads, filter and calibration and waveform monitoring facility.
- 4. Should have option to freeze the real-time ECG waveform.
- 5. Should have facility to enter patient data entry (name, ID, age, gender, height, weight, etc.).Should provide all intervals like PR, QRS, QT, HR, RR etc.
