**Subject: Short rate enquiry (LIMITED TENDER) for the purchase of Two nos. of Life Support full Body Manikin with Inbuilt Integrated Skill Reporter (LSFBMIISR).** The detail specification is as under: -

1. It should have feature to create natural obstruction of airway which allows students to learn the important skill of opening the airway.
2. There should be visible chest rise with correct ventilation
3. It should allow head tilt, chin lift and jaw thrust maneuvers necessary while resuscitating real victims.
4. It should provide realistic chest rigidity and resistance for chest compressions which allows the students to experience the amount of pressure needed to perform proper chest compressions in a real life situation.
5. The manikin should have anatomically correct landmarks and sternal notch which allows to practice identification of all anatomical landmarks relevant to adult CPR.
6. Articulating arms, legs and head should allow realistic weight handling of an adult during obstructed airway maneuvers.
7. Carotid pulse simulation to realistic check for pulse should be feature.
8. It should have an in built feedback monitor which is integrated within the manikin that allows monitoring of chest compression depth, wrong hand position, ventilation volume and stomach inflation.
9. It should have a hygienic system that protects students from cross-infection.
10. Should be supplied with 5 face pieces and 100 head bags
11. Should be supplied with a storage bag with mat.
12. 2 year warranty with 3 year Comprehensive Maintenance Contract
13. Product Demonstration is required before the technical committee.
14. The unit should have US FDA/ CE (Europe) and ISO Certification.

**Term& Conditions: -**
